

Official Rules: Central Oregon Starter Pack Sweepstakes

AGREEMENT TO RULES: Participation in the **Central Oregon Starter Pack Sweepstakes** (“Sweepstakes”) constitutes your full and unconditional agreement to and acceptance of these Official Rules and the decisions of Visit Central Oregon (“Sponsor”), which are final and binding.

ELIGIBILITY AND RESTRICTIONS: Sweepstakes is open to people 21 years of age or older who are legal residents of the 50 United States and District of Columbia, except where prohibited by law. Sweepstakes is subject to all federal, state and local laws and regulations and is void outside of the 50 United States and the District of Columbia and where prohibited by law. Employees of Visit Central Oregon (VCO), all vendors contracted to VCO, their affiliates, subsidiaries, licensees, advertising/promotion agencies, wholesalers, retailers, their immediate family (spouses or children) and persons living in the same households of such employees are ineligible.

You may also print and mail your entry with your name, address, email address, phone number and date of birth to Visit Central Oregon, PO Box 4489, Sunriver, OR 97707. Paper entries must be received no later than February 28, 2021. Limit one entry per person and per household. Entries must be legible to be valid. Sponsor is not responsible for typographical or printing errors, lost, late, damaged, undeliverable or misdirected entries or postage-due mail. Entry forms distributed where prohibited by law, or not obtained lawfully, will be null and void. All entries become the exclusive property of Sponsor and will not be returned. Winners will be notified by email. Any use of robotic, automatic, macro, programmed, third party, or like entry methods, will disqualify all entries using such methods. In case of dispute, the authorized subscriber of email account used to enter the Sweepstakes, at actual time of entry, will be deemed to be participant and must comply with these Official Rules. The authorized account subscriber is deemed to be natural person who is assigned the email address by an Internet Access Provider, online service provider, or other organization that is responsible for assigning email addresses.
